## PRESIDENT'S REPORT

One of the great strengths of our relatively small Association is the diversity of its membership: there is diversity of disciplines, geography, perspectives, identities, and more. One only has to flip through the pages of the Canadian Journal of Law & Society or peruse the program schedule from one of our recent annual meetings to see the diversity of disciplinary approaches and research topics.

On the subject of greater geographic diversity, we are pleased to be holding our Mid-Winter Meeting on the East Coast. This is a first for the CLSA, I believe, and long overdue. We look forward to meeting at St. Mary's University in Halifax on January 23<sup>rd</sup> and 24<sup>th</sup>, 2009. Diane Crocker (St. Mary's) and Jane McMillan (St. Francis Xavier) planning the program and we can anticipate a rich day of workshops and panels, along with some maritime hospitality, perhaps even a kitchen party!

Looking a little further ahead, we will be convening at Carleton University in Ottawa next May for our Annual Meeting, as part of the Congress of Social Sciences & Humanities. One goal for the 2009 meetings is to build on the success of the Montreal meetings by working to increase the level of exchange between English and French-speaking socio-legal scholars. We are grateful for the funding from Canadian Heritage that made some simultaneous translation possible in Montreal and we hope to make use of such funding again in Ottawa. The organizing committee for next year's conference to be held May 23-25, 2009 is headed up by Nicolas Carrier (Institute of Criminology & Criminal Justice, Carleton), Dianne George (Law, Carleton), and Neil Sargent (Law, Carleton). We look forward to three days of engaging panels, graduate student events, and opportunities to connect with colleagues from across the country. See the call for papers later in this Bulletin.

As always, the work of the CLSA is entirely volunteer-driven, and I am grateful to all of you for your participation.

## Joint CLSA-CALT Task Force on Legal Education

Earlier this year, CLSA members who teach and research in Canadian law faculties became aware that the Federation of Law Societies had struck a Task Force on the Accreditation of Canadian Common Law Degrees. Among other issues raised by the Task Force, concerns have been expressed about the implications for socio-legal teaching and scholarship of the proposal to articulate "framework competencies" (doctrinal knowledge, skills, etc.) that law school graduates must demonstrate to be eligible for admission to the legal profession.

The CLSA and the Canadian Association of Law Teachers have struck a joint committee of CLSA/CALT members with expertise in matters of legal education, socio-legal research and scholarship to prepare a position paper to be submitted to the Task Force. That joint committee, which is chaired by Roderick MacDonald of McGill, and includes Diana Majury (Carleton), Richard Devlin (Dalhousie), Hester Lessard (UVic), and Annie Rochette (UQAM), will be working throughout the Fall on its report to be submitted to the Task Force in December 2008. We have also struck an Advisory Committee consisting of Constance Backhouse, Harry Arthurs, Wes Pue, Susan Boyd, Martha Jackman, John Burrows, Lorne Sossin, and Kim Brooks, all of whom will also bring their considerable expertise to bear on the issues. I thank everyone who is working on this important initiative. I urge you to read the Task Force's Discussion Paper which can be found at

## 11) Other Business

Robert Leckey briefed the AGM on the conference panel held yesterday with law teachers concerned about the future regulation of legal education. The concern is that provincial law societies are moving towards a greater degree of direct regulation of programs designed to graduate people such that they are qualified for the bar. Two task forces are currently underway, one of the Federation of

Law Societies and the other of the Law Society of Upper Canada. Such regulation might take the form of lists of required competencies focused on traditional 'core' courses. Robert asked to strike a subcommittee of CLSA to draft a position paper responding to the two task forces, in particular to the Federation's Consultation Paper due in June. Susan Boyd notes that the more mandatory requirements placed on law school pedagogy might reduce the enrolment of students in Law and Society courses and thus the eventual offering of such courses. This potential regulation is thus a key issue for CLSA.

**4. International Journal of the Legal Profession**

**Theme: Impact of Legal Change on Legal Practitioners**

The *International Journal of the Legal Profession* invites submissions for a symposium on how legal changes impact the day-to-day work of legal practitioners. The types of issues that would be appropriate for articles includes how legal change impacts such things as the market for specialized legal practices, lawyers' decision making practices about which cases to pursue, the way lawyers handle specific types of cases, or how lawyers work with experts; these topics are meant to be suggestive not exhaustive. While the examples are drawn from the U.S. and the U.K., submissions dealing with the impact of legal change on legal practice in other countries is strongly encouraged.

The symposium editor will be Professor Herbert Kritzer, William Mitchell College of Law ([herbert.kritzer@wmitchell.edu](mailto:herbert.kritzer@wmitchell.edu)). Authors who have questions about whether their work would be appropriate for the symposium should contact Professor Kritzer.
